#### PRIZE DRAW TERMS AND CONDITIONS

These are the terms and conditions on which you agree to participate in Maroondah City Council's Winter Wonderland 2022 Hamper Prize Draw. #### **PROMOTER DETAILS**

1. The giveaway Promoter is Maroondah City Council (ABN 98 606 522 719)

### **ELIGIBILITY CRITERIA**

- 2. Entry for this prize draw is open to the public who make a purchase of \$50 or more at participating retailer within the McAdam Square precinct as dictated by the Maroondah City Council by the closing date of 5pm Saturday 13 August 2022.
- 3. Entrants under 16 years of age must have parental/carer consent to enter their details.
- 4. Only one entry per \$50 or more spent at participating retailers will be eligible.
- 5. Entries must be submitted by 5pm Saturday 13 August 2022.

# **PRIZE**

6. There will be two (2) prize draws and two (2) winners.

The first drawn winner will receive one large prize hamper consisting of various goods from participating retailers. The second drawn winner will receive one small prize hamper consisting of various goods from participating retailers.

- 8. The winners will be contacted by email or phone number as provided on the entry form within one (1) week of the draw date.
- 9. In entering the prize draw, the winner agrees to participate and co-operate as required in all editorial activities relating to the Prize draw.
